# Oversight group for RCP activity linked to physician associates (known as the PA oversight group):

# **Terms of reference**

August 2024

# The need and scope

The RCP has committed to delivering the <u>recommendations</u> of the post-EGM <u>short life working group</u> (SLWG) on physician associates (PAs). Reporting to the Strategy Executive Group (SEG), Medical Specialties Board (MSB) and RCP Council, the PA oversight group will oversee PA-related workstreams, including:

- > ensuring a coherent approach to work and issues concerning PAs across the RCP and with medical specialties
- > the delivery of the recommendations of the post-EGM short life working group based on the <u>five</u> motions voted for by the fellowship
- > the publication of RCP guidance and policy positions concerning PAs
- > contributing to the work of specialist societies as they develop specialty-specific guidance for PAs.
- > the development of a longer-term RCP approach to workforce planning (by a group which includes early career doctors and PAs, and considers a variety of regional perspectives) and governance, leading to a consistent set of messages for use with external stakeholders
- > developing the approach to the future of the FPA, including the transition to a separate/independent membership, legal and financial entity from the RCP.

The life cycle of this group will be determined by the delivery of the above workstreams.

## Ways of working

- 1. The oversight group may call on RCP and Faculty of Physician Associates (FPA) officers and staff for insight into issues, relationships, context and complexities.
- 2. Written work will need to happen outside of the meetings, and tasks may be allocated to working group members, who may need to commit time during this period.
- 3. While reporting to the oversight group, major pieces of work such as the FPA transition and support to specialist societies will need their own dedicated resource.
- 4. The chair will keep RCP senior leadership updated on progress through SEG and senior officers.
- 5. Progress will be shared with RCP Council and the Board of Trustees.
- 6. Confidentiality of discussions and documents should be maintained by all members.
