Professor Nicola Pavese

Professor Nicola Pavese is director of the Clinical Ageing Research Unit at Newcastle University and lead of the Parkinson's Research Team. Nicola's research focuses on elucidating the physiopathology of Parkinson's and other neurodegenerative diseases, as well as identifying targets for treatment. He has published over 200 reports in high impact journals, reviews, books, chapters and editorials.



Dr Faye Wilson

Dr Faye Wilson has worked as a consultant orthogeriatrician in Sunderland since 2014. She completed both her undergraduate and postgraduate training in London and, prior to taking up her consultant post, completed a fellowship in orthogeriatric medicine at Imperial College London and a masters degree in Cardiff.



Professor Fraser Birrell

Professor Fraser Birrell is an honorary professor of lifestyle medicine and innovation at Newcastle University, consultant rheumatologist at Northumbria Healthcare NHS Foundation Trust, visiting professor at Northumbria University, and adjunct professor at Southern Cross University.

Fraser is also engagement lead at MRC-Versus Arthritis Centre for Integrated Research into Musculoskeletal Ageing, director of science and research at the British Society of Lifestyle Medicine, editor-in-chief of Wiley open access journal 'Lifestyle Medicine, and senior author of An Essential Book of MCQs for Certification in Lifestyle Medicine.

Fraser is passionate about education, holds principal fellowship of the Higher Education Academy, and has won awards from the British Society for Rheumatology and the RCP's Excellence in Patient Care Awards. He also has a professional interest in lifestyle medicine and received inaugural fellowship of the British Society of Lifestyle Medicine.

He is a passionate advocate of multidisciplinary care, scholarship and learning, and relishes in the opportunity to share a case-oriented and evidence-based approach to managing rheumatology patients in the Acute Medical Unit, as well as taking a longer and broader view of how we can turn the tide of ever -increasing medical admissions.



Dr Timothy Hardy

Dr Timothy Hardy is a consultant hepatologist at James Cook University Hospital. Tim received pre-doctoral funding to complete a PhD investigating the role of DNA methylation human steatotic liver disease in 2019, and has also received postdoctoral funding from National Institute of Health and Research. Tim is currently co-leading the NIHR Tees Valley MASLD Research Partnership which focuses on early detection and management of human steatotic liver disease.



Dr Dina Mansour

Dr Dina Mansour is a consultant gastroenterologist and hepatologist at Queen Elizabeth Hospital in the north-east of England. She is a senior clinical lecturer at Newcastle University and secretary of the liver section of the British Society of Gastroenterology. Dina has an interest in liver research and quality improvement and is the first author on the three-part BSG guidance document on the outpatient management of cirrhosis, recently published in *Frontline Gastroenterology*. She is the chair of the Guideline Development Group, developing the revised BSG guidelines on varices and variceal haemorrhage, and is leading on the development of a quality standards framework for liver disease.



Dr Michael Drozd

Dr Michael Drozd is an IMT3 and cardiology ACF at Leeds Teaching Hospitals. After his foundation training, Michael completed a BHF funded PhD investigating IGF-1 signalling in atherosclerosis. He now conducts research investigating the mechanisms of infection in people with cardiometabolic disease. Michael has been elected as a fellow of the European Society of Cardiology for scientific excellence.



Dr Ahmed Hanafy

Dr Ahmed Hanafy is a consultant in diabetes and endocrinology at James Cook University Hospital. He has completed higher specialty training in diabetes, endocrinology and general internal medicine in Leeds.

Ahmed's special interests are cardiometabolic medicine, diabetes technology and adrenal diseases.

Dr Ishara Ranathunga is an associate specialist in diabetes and endocrinology. She is also clinical lead of the tier 3 Weight Management Service at North Cumbria Integrated Care NHS Foundation Trust.

Dr Honey Thomas

Dr Honey Thomas is a consultant cardiologist based in Northumbria Healthcare NHS Foundation Trust. She completed cardiology training and a postgraduate MD qualification in the north-east, developing a subspecialty interest in heart failure and advanced rhythm management/complex device implantation. Honey introduced and leads the local heart failure service for implantation and follow-up of complex cardiac devices.

She jointly leads cardiology research in Northumbria healthcare and acts as principal investigator on several multi-centre NIHR trials, as well as being a member of the Examination Board for the British Heart Rhythm Society professional accreditation qualification. Honey has also worked closely with the British Heart Rhythm Society to develop and share a national guidance document for perioperative management of cardiac implantable electronic devices.

She has a major interest in atrial fibrillation and is passionate about improving the quality of care in this area, developing local and regional pathways to try and optimise the care of patients with AF. She currently chairs the cardiac rhythm management subgroup of the Northern England Clinical Network Specialty Group.
